SAMPLE CUSTODY AND STORAGE

To insure correct receipt and handling of your sample, please forward a chain-of-custody form containing the following information:

- Full name, address, phone number of the person to whom the report and invoice are to be mailed.
- Purchase order number, if applicable.
- Complete details of sample identity and analysis required.
- If the client desires results by telephone/fax, give the name and numbers of the person to be called/faxed.
- Please provide adequate sample volumes for all requested analyses; if you are in doubt, call the lab.

SAMPLE CONTAINERS

San Antonio Testing will provide sample containers, upon request, at no extra charge. Shipping costs will be paid by the client.

SAMPLE DISPOSAL

After issuing the final report, the remaining portions of the samples will be stored for 30 days and then disposed of. Sample can be kept for longer than 30 days at customer's specific request.
